WHO WE CAN HELP:

We prioritise those in regional and remote areas, people experiencing family violence, children and young people, indigenous Australians, people with a disability or mental illness and older people.

WHAT WE CAN HELP WITH:

We provide free legal advice on a range of issues including family law, family violence, separation and divorce, youth law, motor vehicle accidents, credit and debt issues, discrimination, consumer complaints, traffic offences, fines, seniors' issues and other everyday legal problems.

There are some legal problems we do not help with, like bankruptcy, conveyancing and commercial matters but if you call us, we can refer you to someone who can help.
